- 5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting

- 6. Pre-bid meeting shall be held at *Transport Infrastructure Directorate*, *Hetauda* at 13:00 PM, 2077/06/09
- 7. Bids must be submitted only by e-Bidding through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hrs on 2077/06/18 Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2077/06/18 at the office of Transport Infrastructure Directorate, Hetauda. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned in the table above, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077/11/18)
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
